2. Bagi pelajar mod kerja kursus/campuran mesti menunjukkan peningkatan prestasi akademik iaitu PNGK meningkat dan mencapai sekurang-kurangnya PNGK 2.90; dan

Guideline to Candidates for Appeal:

I. Dismissed due to failure to register

1. *This appeal is to be submitted no later than a period of not exceeding two (2) consecutive semesters after dismissal; and*
2. *Each application must be submitted together with the proof of payment of RM250.00.*

II. Dismissed due to unsatisfactory academic performance

1. *This appeal is to be submitted no later than the fourth (4th) week after the official examination results are released OR 28 days after the revocation of your student status;*
2. *Students from coursework/mixed mode must show an improvement in academic performance with increased CGPA and achieved at least a CGPA of 2.90; and*
3. *Each application must be submitted together with the proof of payment of RM100.00.*
