5. The INDIVIDUAL may only publish findings of the research conducted at IMEN with the agreement if his or her project leader or supervisors.
6. The INDIVIDUAL may only present findings of the research conducted at IMEN at conferences, seminars or other forums with the agreement of his or her project leader or supervisors.
7. The INDIVIDUAL, if registered as a post-graduate student with the UNIVERSITY, may use the findings of the research conducted at IMEN for the purpose of completing a thesis under the supervision of his or her project leader or supervisors
