PROGRAMME REQUIREMENTS

ACADEMIC QUALIFICATION

A Bachelor of Law (Honours) degree, or a Bachelor of Law or Syariah (Honours) degree from UKM or any institution of higher learning recognised by the UKM Senate with a minimum CGPA of 3.00.

For a candidate with **CGPA of 2.70-2.90**, the candidate is required to have **three (3) years** of working experience in the legal and judicial services or related field and the Faculty Graduate Studies Committee must also be satisfied that the candidate is able to pursue the Master programme.

For a candidate with CGPA of 2.69 and below, the candidate is required to have seven (7) years of working experience in the legal and judicial services or related field and the Faculty of Graduate Studies Committee must also be satisfied that the candidate is able to pursue the Master programme.

PROGRAMME STRUCTURE

MODE: COURSEWORK ONLY

For the Master of Laws programme through coursework only, it is compulsory for a candidate to complete ONE (1) compulsory course UK6215 Legal Research Methodology and SEVEN (7) elective courses. Each course whether compulsory or elective is equivalent to 5 units. The total number of units for coursework only 40 units.

For full time candidates, the total number of units for coursework per semester is a maximum of 20 and a minimum of 10.

For part-time candidates, the total number of units for coursework per semester is a maximum of 10 and a minimum of 5.

Candidates must maintain a minimum **CGPA of 3.00** to be awarded a degree.
